January 18, 2024

There was a Commissioners meeting at 2:00 PM in the Commissioners Conference Room at 700 Sawmill Road, Small Conference Room for the regular scheduled Commissioners meeting. In attendance were Commissioners Brewer, Karschner, Kovach, Solicitor McDonald, Prothonotary Stroup, Treasurer Creveling, Jean Lapinski, Michele Frye, and Marcie Strachko. Via zoom were the following individuals Jenn Long, Don Coleman, Jodi Cook, MJ Mahon, Janelle Neidig, Tim Murphy and Kelly O'Brien.

Commissioner Brewer called the meeting to order and asked that we stand and pledge the flag, he then called for the approval of the minutes of the prior meeting.

Commissioner Brewer then called for a report of the work session: There was a 10:00 work session held. In attendance were Commissioners Brewer, Kovach, Karschner, Solicitor McDonald, Treasurer Creveling, Prothonotary Stroup, Marcie Strachko, Jean Lapinski, Michelle Frye, Betsy Rubio, and MJ Mahon. Betsy Rubio explained she was there for two items. Betsy said Lori Gordner will come out of retirement and serve as the interim Certifying Office for Environmental Review records until a permanent Executive director is found. It was acknowledged that the loss of Matt Hess is huge and we are lucky Lori is helping out. Betsy also asked for the approval of a six-month extension on the CDBG contract C000075689 for 2020. She mentioned Briar Creek is selling a parcel on Summerhill Road and they are looking for a donation for property on Back Branch Road. Janelle Neidig needs approval of the 2024 PA SAVIN contract which is afforded to victims regarding certain notifications related to incarcerated individuals. The agenda was reviewed by Marcie Strachko with the first item being approval the advertisement for the lease of the Columbia County farm for farming purpose. The warden is seeking approval to use commissary money for the following upgrades: Prison's WIFI \$44,642, Beacon Upgrade \$41,783 and the Control Panel Upgrade \$163,400. Jenn Long needed Commissioner Karschner's signature for the Local Emergency Planning Committee (LEPC) letter that goes to PEMA. Lastly, approval of tax/cost/interest moved out of campground with no permit: Parcel #20-06-004-01,184 in the amount of \$119.88. A motion was made to add to the 2:00 Meeting a discussion of Castle Consulting's recommendation for the Retirement Fund. Karschner made the motion and Kovach seconded; all approved. Marcie then reviewed the hires, step increase, promotions for both the Commissioners and Courts along with resignations, terminations, and retirements. Jean reviewed available cash is \$3,135,931.72 as well as the bills for the last pay period of 1/5/24. After that, Kovach made a motion to adjourn the meeting; Karschner seconded. Brewer declared meeting over.
