Commissioner Young called the meeting to order and asked that we stand and pledge the flag, he then called for the approval of the minutes of the prior meeting.

Report of the work session: There was a 10:00 work session held. In attendance were Commissioners Young, Ridgway, Kovach, Solicitor McDonald, Chief Clerk Witchey, Harry Mathias, Michelle Frye, Treasurer Creveling, Marcie Strachko, Bob Christianson, Matt Hess, Donald Lyken, and Jean Lapinski. Rachael Swartwood Julye Wemple, and Tim Hippentsteel. Via Zoom were the following individuals: Don Coleman, Eric Stahley, Tim Murphy, Jenn Long, Troy Litwhiler, Wade Mays, and Geralee Zeigler. Commissioner Young called the work session to order and asked Harry Mathias to start the meeting by discussing his recommendations for the American Rescue Funds. Harry stated that he had 5 different recommendations, the first being HVAC equipment for the Bloomsburg Theater Ensemble for \$130,880. The next recommendation was \$25,000 to the Town of Bloomsburg for their sewer authority to improve efficiencies and drive down costs. Recommendation three was \$50,000 for the Children's Museum for an outdoor learning space. Item four is for the Dental Health Clinic and that is in the amount of \$53,600 for digital scanning and the repair/replace of a broken dental chair. And the fifth and last recommendation is for the Town of Bloomsburg up to \$355,000 with up to \$250,000 for the little league field, \$65,000 for MS4 and \$40,000 for a community basketball court. Bob Christianson then briefly discussed Suez's plan for installing water in South Centre Township. Troy Litwhiler then wanted discuss Bridge #27 located in Cleveland Township and he wanted to voice the Townships displeasure regarding the proposed deck replacement he also stated that the local police and fire had concerns that are being ignored by the Commissioners. Commissioner Ridgway then said that they had conversations with the police and Fire Company and then told Troy that we would work with you but then you (Troy) went to DEP and asked them to deny permit for the deck replacement. Commissioner Ridgway then stated that the County has 58 other bridges within the County that they need to worry about, Commissioner then had Troy cutoff from making any other comments. Matt Hess then discussed some of his concerns with ERAP2 regarding the guidance changes where the payment goes to the applicant and not the landlord, and the other proposed change which Matt also objects to is the self-certification of income vs proof of income. Matt has proposed that he will continue the payment of funds to the landlord and also proof of income with the blessing of the Commissioners. Chief Clerk Witchey gave a brief update regarding the WVWM Funds and it was agreed to keep on the agenda until next meeting. Marcie reviewed all the personnel moves. Jean then reviewed cash and bills; the rest of the agenda was reviewed and then both the Salary Board and Retirement Board agendas were reviewed and then the meeting was adjourned.
