- 7. \$9,360 to Columbia Montour SWAT for Communication Equipment.

Matt Hess provided an update on the ribbon cutting of the West Street Church and that DCED recommended an extension to September which does require Commissioner sign off. Penn State then discussed Extension Day in the County which is scheduled on May 12th at Sawmill in the large Confrence room. They were hoping to have County Department Heads also attend the meeting. Penn State then introduced the new horticulture individual, she provided a brief update of what is going on in the County then Suann Leighow from the Master Gardner spoke about tics and the new deer tick virus. The Historical Society then presented their current situation that is requiring them to move to a new location. They reviewed their history and their need to expand. The Commissioners then said instead of using American Rescue Funds this fits more into the Historic Preservation which allows Visitors Bureau funds to be utilized. Bob Christianson then discussed that the Sewer Project is moving forward and that they will be finalizing the Penn Vest application. Geralee from SEDA-COG then discussed item C on the agenda which is the \$2.3 million in engineering for the levee control system.
