NEW BUSINESS:

A. NEW ANNUITIES OF RETIRED MEMBERS

- **Anthony McDonald selected Option Two:**  
A monthly benefit payable for the rest of his life, and upon his death, the same monthly benefit will continue to his beneficiary, if still living. The combined total he and his beneficiary are guaranteed to receive is his member account balance of \$59,566.08

E. DEATHS

- **Charles W. Robsock, September 19, 2024**  
Option One: A monthly pension of \$38.91 payable for his lifetime. Should he fail to receive payments at least equal to the present value of his retirement allowance of \$4,901.57, the balance shall be paid to his designated beneficiaries.  
Mr. Robsock exceeded his accumulated deductions of \$4,901.57, therefore, there isn't any funds left for a beneficiary.
  - DOH: 1/2/90
  - Retired: 10/19/91, worked 1 year, 9 months as a deputy sheriff
  - Over 33 years, he collected approx., \$15,400.00
- **Ms. Karen Brenchley October 7, 2024**  
Option Three (3): A monthly pension of \$456.14 payable for her lifetime. If she predeceases her designated survivor annuitant, the survivor annuitant will receive a monthly pension of \$228.07 (50% of her pension) for the rest of his lifetime. If both she and the survivor annuitant die before the cumulative pension payments equal or exceed \$30,274.04, the amount of her accumulated deductions at her annuity start date, her designated beneficiaries would receive a lump sum payment equal to the excess of her accumulated deductions over the cumulative pension payments received to date.

Mr. Frank Brenchley will receive the survivor annuitant in the amount of \$228.07 each month for the duration of his lifetime.

- 13 years, collected \$76,631.52 (to date)
