The Columbia County Commissioners met on the above date at 2:00 PM in the Commissioners' Conference Room at 700 Sawmill Small Conference Room for a Commissioners meeting handling the transaction of routine business. In attendance were Commissioners Young, Ridgway, Kovach, Solicitor McDonald, Marcie Strachko, Treasurer Creveling, Jean Lapinski, Michelle Frey, and Don Coleman. All other attendees were online via zoom they are as follows Eric Stahley, Jeremy Brown, and Eric Boughner.

A motion was made by Kovach and seconded by Ridgway to approve the minutes of the last meeting. The motion was unanimously passed.

There was a work session at 10:00 AM in the Commissioners Conference Room at 700 Sawmill Small Conference Room for the transaction of routine business. In attendance were Commissioners Young, Ridgway, Kovach, Solicitor McDonald, Marcie Strachko, Treasurer Creveling, Jean Lapinski, Michelle Frey, Susan Swartz, Tom Dougher, Thakore Krunal, and Harry Mathias. All other attendees were online via zoom they are as follows Barb Warnuk, Eric Stahley, Jeremy Brown, Sheriff Chamberlain, Jen Long, Wade Mays, Dan Knorr, and Eric Boughner. Harry discussed the Geisinger Morgue and with the Solicitors blessing that the Commissioners sign the agreement. As of the day of the meeting the small business grant requests are \$185K and Harry anticipates utilizing all of the 225K of the grant. He also discussed the two County grants of 100K and 250K and that we need to determine how much of those funds can be reallocated to other programs. The Commissioners presented the Gatehouse a Proclamation for National Homelessness and Hunger Week and then discussed CSG's West Street Church project. There was a COVID-19 discussion regarding Columbia County's total and Dan Knorr discussed Bloomsburg University's positive cases. Wade discussed the landfill and the Park projects, and Treasurer Creveling discussed the fact that State will reimburse the County for the postage for dog license notifications which is about 4K. Susan Swartz had questions regarding the Morgue project. Nikki Krize had a voting question regarding mail in ballots due to a comment from an individual stating that they had walked out when processing mail in ballots for Columbia County and that he ran across his dead grandmother's ballot. Since Columbia County had completed our processing election night, the Commissioners said this comment was invalid.
