There was a Commissioners meeting at 2:00 PM in the Commissioners Conference Room at 700 Sawmill Road, Small Conference Room for the regular scheduled Commissioners meeting. In attendance were Commissioners Brewer, Karschner, Kovach, Treasurer Creveling, Solicitor Marinos, David Witchey, Marcie Strachko, and Michelle Frey. Via Zoom were Jeremy Brown, Jenn Long, Jeannie Lapinski, and MJ Mahon.

Commissioner Brewer called the meeting to order and asked for a motion to approve the minutes of the prior meeting.

Motion was made by Treasurer Creveling and seconded by Commissioner Kovach; all approved.

OLD BUSINESS: None

A. NEW BUSINESS: NEW ANNUITIES OF RETIRED MEMBERS

- **Denise Labuda** - selected **Option Four C**: A lump sum payment of her member account balance plus a monthly benefit payable for the rest of her life, and upon her death, the same monthly benefit will continue for her designated beneficiary, if still living.

Lump Sum Benefit: \$169,338.09 payable to Denise LaBuda plus
Monthly Benefit - \$1,774.57 / Beneficiary Monthly Benefit: \$1,774.57 plus a partial payment for October 2025 of \$515.20

E. DEATHS

- **David C. Champ** passed away on October 30, 2025. He had selected Option Three (3): A monthly pension of \$1701.08 payable for his lifetime; a monthly payment of \$850.54 (50% of his pension) for his survivor annuitant
Mr. Champ exceeded \$98,451.00, and his survivor annuitant has passed away, therefore there are not any funds left for a beneficiary
- **Edda McDonnell** passed away on November 22, 2025. Ms. McDonnell selected No Option: A monthly pension of \$1,141.00 payable for her lifetime. Should she fail to receive payments at least equal to her accumulated deductions of \$46,199.17, the balance shall be paid to her beneficiaries. Ms. Edda McDonnell exceeded \$46,199.17; therefore, there are no funds available for her beneficiaries.
- **John W. Morrison** passed away on November 25, 2025. Mr. Morrison selected Four (B): he elected to withdraw, in one payment, the total accumulated deductions of \$2,762.10 in addition to receiving a monthly annuity of \$35.49 payable throughout his life. Should he fail to receive monthly payments at least equal to the present value of the county annuity of \$3,724.84, the balance shall be paid to his designated beneficiary. There are no funds available for a beneficiary.
